Payment for merchandise is due before ordering or use.

Lee Funeral Home & cremation service does not accept future payment from estate funds.

## **ACCEPTABLE PAYMENT OPTIONS**

Cash or personal check. We don't accept post-dated checks.

Visa, Master Card, Discover, American Express – a 4% fee added to the transaction.

Insurance assignment.

Available to beneficiary (s) only.

Policy must be verified.

Policy must be older than 2 years.

All beneficiaries must sign the paperwork provided by LFH in front of notary.

Beneficiary must sign within 24 hours of verification.

A 5% (\$100 minimum) fee of the total funeral home charges will be charged.

## **FAMILY VIEWING POLICY**

Family viewing is for family members only.

The funeral home will not be open to the general public.

Viewing is for 1 hour.

## **IDENTIFICATION VIEWING POLICY**

ID viewings are solely for those decedents whose identification is in question. Viewing is limited to 15 minutes and immediate family only (spouse, child, sibling).

## **EMBALMING POLICY**

LFH requires that embalming be done when there is public viewing.

### **Embalming**

**\$435**

Except in special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want Embalming, you usually have the right to choose an arraignment that does not require you to pay for it, such as direct cremation or immediate burial.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a woodgrain viewing bed, standard white coverlet, and economy fiberboard.
